CEETTAR Position Paper on the FARM to FORK STRATEGY

Contractors already contribute to a sustainable food system

CEETTAR share the European Commission concern on the need to build both a competitive and sustainable future for animal and human food production in Europe.

Contractors are using innovative and precision farming techniques on agricultural lands. These practices are reducing the quantity of necessary plant protection products. Hence, contractors are already directly contributing to reach the 50% reduction target in the use of pesticide by 2030, as planned in the Farm to Fork Strategy.

Due to the contractual provisions between Contractors and farmers, contractors need to be able to report on all the work done. This requirement makes environmentally friendly performances easier to monitor and control. Data management and date sharing create new business opportunities for contractors and broadens the scope of their activities. These changes bring additional guarantee both to the farmer and to the contractor that work is performed while respecting agreed quality standards in terms of environmental protection.

By using more advanced technologies, contractors are already equipped than to demonstrate their benefit in term of compliance with the Farm to Fork strategy.

What is CEETTAR asking for?

- CEETTAR underline the importance of basing decisions on sound evidence from an economic, environmental and social point of view and demand a systematic impact assessment for each new legislative proposal in support to the Farm to Fork Strategy;
- The implementation of the Farm to Fork Strategy should be accompanied by transparent and appropriate indicators to assess how agricultural competitiveness, income and remuneration for new services are improving, together with the effects on environment and food security;
- The Farm to Fork Strategy supports the creation of new business models, which are green, profitable and compatible with the EU Green Deal (which also includes the Biodiversity Strategy and the new EU Forestry Strategy). In order to make EU agriculture both competitive and sustainable, CEETTAR is pleading for a better

coherence between the Common Agriculture Policy (CAP) and the entire Green Deal package.

On the support to innovation side, CEETTAR would like to recall the need to promote
effective Agricultural Knowledge and Innovation Systems (AKIS), which is enabling all
actors to become sustainable by speeding up innovation and accelerating
knowledge transfer. In addition, a farm sustainability database should set benchmark
for farm performance and document the uptake of sustainable farming practices.
To implement this process, CEETTAR pleads for the extension of access to fast
broadband connections in rural areas.

Additional remark on the Integrated Pest Management (IPM) Directive and use of plant protection products.

CEETTAR welcomes the fact that the current revision process of the IPM 2009/128/14 Directive takes into consideration the repercussion of a more stringent application of IPM on economic operators involved in the distribution and use of pesticides, which includes contractors. In addition to this, the revision process of the various legislations on plant protection products (such as the Regulation EC 1107/2009 concerning the placing of plant protection products on the market) must encompass the new spraying techniques, as already employed by contractors.

By complying with the changes in product authorisation, contractors can propose tailormade solutions to farmers and forestry owners. These changes also generate additional business opportunities for contractors, as they are more equipped to adapt to changing circumstances and to use alternative products launched on the market containing newly approved active substances.

Against this background, contractors are joining the machinery industry, machinery dealers, pesticides companies and the entire agriculture value chain in their effort to launch alternative products and machinery on the market, based on increased research programmes.
